

## HPM Maui DeWalt Extreme Giveaway Official Rules

February 17, 2024 - February 21, 2024

**Sponsor:** HPM Maui DeWalt Extreme Giveaway (the "Giveaway") is sponsored by DeWalt (the "Sponsor"), 16-166 Melekehwiwa Street, Keaau, Hawaii 96749.

**Eligibility:** The Giveaway is open only to legal Maui County residents who are 18 years of age or older at time of entry. Owner-employees and immediate family members of HPM Building Supply are not eligible to enter. Participants may better their odds of winning by tagging more of their friends. One comment with a tagged friend is equivalent to one entry. Entrants may submit unlimited entries on HPM's Facebook and Instagram social media accounts.

**The Winner's Responsibility:** There are no substitutions, exchanges, or transfers of Prizes by Winner. Winner is responsible for all taxes and fees associated with the prize receipt and/or use. Winner must pick up the Prize within 30 days of initial contact or Sponsor will draw another Winner.

**Publicity:** Except where prohibited, participation in the Giveaway constitutes the entrant's consent for Sponsor to use the Winner's name and photo for promotional purposes in any media without further consent.

**General Conditions:** In the event that the operation, security, or administration of the Promotion is impaired for any reason, including but not limited to, fraud, technical failures,

regularly scheduled maintenance, virus or other technical problems, the Sponsor may, in its sole discretion, either: a) suspend the Promotion and award the prize in a random drawing from among all eligible entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of the Official Rules, or in an unsportsmanlike or disruptive manner. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

All issues and questions concerning the construction, validity, interpretation and enforcement of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Promotion, shall be governed by and construed in accordance with the laws of the State of Hawaii, without giving effect to any choice of law rules (whether of the State of Hawaii or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Hawaii.
