

2026 Suns Out, Decks Out HPM × Fiberon \$30K Deck Makeover Giveaway

Official Rules

July 10 – October 31, 2026

Eligibility: The Giveaway is open only to legal Hawai'i state residents who are 18 years of age or older at time of entry. Owner-employees and immediate family members of HPM Building Supply are not eligible to enter. The Giveaway is subject to all federal, state and local laws and regulations and is void where prohibited by law.

Agreement to Official Rules: By participating in the Giveaway, participants fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Giveaway. Sponsor has the right to revise Official Rules as necessary.

Giveaway Period: The Giveaway takes place on Friday, July 10, 2026 through Saturday, October 31, 2026. The winner will be selected no later than Friday, November 6, 2026.

How to Enter: Participants may enter by completing the online entry form. Alternative entry may be submitted by visiting your nearest HPM Building Supply location and providing an HPM employee owner with your full legal name, phone number, and email address. Employee owners must submit alternative entries to marketing@hpmhawaii.com immediately upon receipt and no later than October 31, 2026. By submitting an entry, participants agree to HPM's Terms and Conditions and Privacy Policy. NO PURCHASE IS NECESSARY TO ENTER.

Prize:

One (1) winner will win the Prize.

- Fiberon composite decking materials purchased through HPM Building Supply at retail price, up to a total prize value of \$30,000
- A check issued by HPM Building Supply made payable to the winner for the remaining balance — calculated as \$30,000 less the retail purchase price of the

Fiberon decking materials selected — to be applied toward contractor labor costs at the winner's discretion

- If the retail price of the selected Fiberon decking materials exceeds \$30,000, the winner is responsible for covering any amount over \$30,000. HPM Building Supply is not responsible for costs exceeding the stated prize value.
- The winner is responsible for selecting and hiring their own contractor. HPM recommends using HPM's Better Builder Directory or Fiberon's Find an Installer tool as resources for finding a qualified contractor. HPM does not install decking and is not responsible for contractor selection, performance, or any labor costs.

The retail value of all prizes, as of the time these Official Rules are published, is \$30,000.00. Any costs exceeding \$30,000 are the sole responsibility of the winner. Any unused portion of the prize value will not be awarded in cash or otherwise.

Giveaway Winner Selection & Verification: One (1) Winner will be randomly selected from all eligible completed entries. The Winner will be contacted via phone call.

The Winner's Responsibility: There are no substitutions or exchanges. Winner must confirm selection within the timeframe communicated by HPM Building Supply or Sponsor will draw another Winner. The Winner will need to present valid government-issued photo identification and sign a media waiver and W9 form upon prize coordination at the agreed upon HPM Building Supply location. As a condition of claiming the Prize, the Winner agrees to allow HPM Building Supply to document the decking project through photography and/or video at various stages of construction and upon completion. HPM Building Supply will coordinate sending an employee or photographer to capture this documentation. Failure to provide reasonable access for documentation purposes will result in forfeiture of the prize and selection of an alternate winner.

Publicity: Except where prohibited, participation in the Giveaway constitutes the entrant's consent for Sponsor to use the Winner's name, likeness, photo, and project photography and/or video — including images and footage captured during construction and upon completion of the decking project — for promotional purposes in any media without further compensation or consent. All photography and video captured by HPM Building Supply or its representatives in connection with the Prize shall be the property of HPM Building Supply.

General Conditions: In the event that the operation, security, or administration of the Promotion is impaired for any reason, including but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problems, the Sponsor may, in

its sole discretion, either: a) suspend the Promotion and award the prize in a random drawing from among all eligible entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of the Official Rules, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Release and Limitations of Liability: Except where prohibited, by participating in the Promotion, entrants agree to release and hold harmless HPM Building Supply, Fiberon, and their respective affiliates, promotional partners, prize partners, agents and agencies and the officers, directors and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of the participation in the Promotion or receipt or use of any prize but not limited to: a) unauthorized human intervention in the Promotion; b) technical errors related to the computers, servers, providers, printers or telephone network lines; c) printing errors; d) errors of the administration or the processing of entries; e) late, lost or undeliverable mail; or f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotion or receipt of any prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Promotion and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including but not limited to, punitive, consequential, direct or indirect damages. If, for any reason, an entrant's entry is confirmed to have been erroneously deleted, lost or otherwise destroyed or corrupted, the entrant's sole remedy is another entry form.

Disputes: Entrant agrees that: a) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate Hawaii State Court located in Honolulu County, Hawaii; b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Promotion, but in no event attorney's fees. All issues and questions concerning the construction, validity, interpretation and enforcement of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Promotion, shall be governed by and construed in accordance with the laws of the

State of Hawaii, without giving effect to any choice of law rules (whether of the State of Hawaii or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Hawaii.
